This is an Agreement between Camp Whiskers (hereinafter called Camp Whiskers) and the pet owner whose signature appears below (hereinafter called "Owner").

1. I, _____, do hereby release, indemnify, and agree to hold Camp Whiskers harmless from any and all manner of damages, claims, loss, liabilities, costs or expenses, including attorney's fees and related costs, arising out of or related to the services provided by Camp Whiskers, except which may arise from the sole gross or willful misconduct on the part of Camp Whiskers. Camp Whiskers agrees to provide all services in a kind, reliable, and trustworthy manner.
2. By signing this Agreement and leaving pet with Camp Whiskers, Owner certifies to the accuracy and completeness of all information given about said pet(s) for all future stays.
3. Owner specifically represents to Camp Whiskers that, to Owner's knowledge, the pet has not been exposed to any contagious diseases within a thirty-day period prior to check-in and is reasonably believed to be symptom-free at the time of check-in. Owner further agrees to maintain currency of FVRCP vaccination and Rabies vaccination and to provide proof thereof prior to boarding pet at Camp Whiskers. In addition, a current negative FIV/FELV test is required for all long-term (monthly) boarding pets wishing to socialize with other long-term boarding pets in the play room. Owner agrees to allow pet to have interaction with other pets while in the care of Camp Whiskers (long-term only with proof of negative FIV/FELV test).

4. Owner agrees to pay all costs and charges for boarding fees, all required flea treatments, and all veterinary costs for the pet during the period said pet is in the care of Camp Whiskers. All of the above charges and fees are collectively called "Total Charges".
5. Owner further agrees that the pet shall not leave the facility until the total charges are paid. Owner agrees that fees will continue to accrue at the agreed rate for the entire period a pet remains in the care of Camp Whiskers due to nonpayment of Total Charges.
6. Boarding Fees to be incurred by Owner shall be payable on a monthly basis for long-term boarders with first month's boarding fee due prior to drop-off and the balance of the Total Charges upon pick-up of pet. Boarding Fees to be incurred by Owner shall be payable for short-term boarders upon pick-up and to include Total Charges upon pick-up of pet.

Camp Whiskers shall have, and is hereby granted, a lien on the pet in accordance with New York State Law for any and all unpaid charges resulting from services provided. The Owner hereby agrees that in the event the charges are not paid when due in accordance with this contract, Camp Whiskers may exercise its lien rights upon ten days written notice given by Camp Whiskers to Owner by certified mail to address shown on contract. Camp Whiskers may dispose of pet for any and all unpaid charges, at private or public sale/adoption, or relinquish pet to a shelter at the sole discretion of Camp Whiskers, and Owner specifically waives all statutory or legal rights to the contrary. Owner shall remain liable to Camp Whiskers for any and all unpaid charges.

Owner agrees to a one-time abandonment fee of \$3,000 if owner abandons pet in the care of Camp Whiskers. Owner's initials: _____

7. If, during our check-in examination or at a later time, we observe evidence of fleas on Owner's cat, we will provide the cat with a flea treatment and take steps to eliminate any fleas from the boarding room. Owner will be charged an additional \$15 fee for this service. We recommend all pets be current on preventative prior to their arrival.

8. If pet becomes ill or injured, or if the state of the animal's health otherwise is reasonably believed to require professional attention, Camp Whiskers, in its sole discretion after making reasonable attempts to contact the Owner or emergency contact, may engage the services of a veterinarian or administer medicine, and the expenses shall be paid by the Owner upon receipt. Owner agrees that Camp Whiskers is approved to obtain both non-emergency and emergency treatment and medication for their pet in their absence at a veterinarian of our choosing. Owner agrees to not hold Camp Whiskers liable for failure to detect an illness or injury, or failure to seek veterinary treatment.
9. This Agreement covers the current and future relationship between Camp Whiskers and Owner. Each time Owner's pet(s) are brought to Camp Whiskers, Owner affirms the terms of this Agreement, and the truthfulness and accuracy of all statements made in this Agreement.
